Opposing Counsel, Unified Hearts

Former legal rivals establish a bequest at Boston College.

At first, it was simply another case.

As young attorneys based in Texas on opposing sides of a case in the early 1990s, they filed briefs and motions against each other for almost two years. They spoke on the phone almost every day, but never met in person—until one day, when she walked into his office for a document production. "What was already a very complicated and difficult case suddenly became much more complicated because I discovered that opposing counsel—Sylvia—was even more remarkable than I could have known," recalls Matthew Kerrigan '82 with a smile. "But I knew the case had to get resolved before I could call her about anything other than the case we were working on for our clients," he says. As soon as it ended, he asked Sylvia out to lunch. "Fortunately she said yes," he adds. "And the rest is history."

Fast-forward through three decades of marriage, and Sylvia and Matt are still collaborating—in their day-to-day schedules and in their lifelong plans. Together, they established a bequest to endow a professorship in the Morrissey College of Arts and Sciences, with a preference for the department of environmental studies.

"We both love nature and the ocean, and we worry about the application of narrow technologies on what is such a vitally, inherently interdisciplinary world," says Sylvia, a corporate attorney who is also a highly experienced scuba diver. "Through this professorship, we want to encourage scholarship that looks at the world from a holistic perspective."

The professorship will be named in honor of Matt's great uncle, William Murphy, S.J., BC's 19th president who served from 1939 to 1945. "One of Uncle Bill's early initiatives was to strengthen and improve education in the sciences," Matt says. "So to be able to make this gift in a way that reinforces and pays tribute to that was just a great opportunity for us. We think that he'd be just delighted with the fact that something he prioritized back in 1939 is what this professorship will support."

Matt remembers "Uncle Bill" coming to the house for dinner for family holidays, and he remembers visiting Fr. Murphy at BC when he lived in St. Mary's. "That's how BC first got on my radar," Matt remembers. As Matt grew older, his dad would bring him and his brothers to campus for the annual BC-Holy Cross football games. "The one

team that my dad most wanted the Holy Cross Crusaders to beat every year was the Boston College Eagles. So he had a friendly rivalry with my Uncle Bill about all of that because Uncle Bill was an Eagle through and through!" Matt says. In 1978, Matt was admitted to BC and invited to join the honors program at the College of Arts and Sciences. "I really enjoyed my time in the honors program and made so many lifelong friends at the Heights," he says.

Early in their dating relationship, Matt introduced Sylvia to campus and his BC friends. They immediately welcomed her into their circle. "Although we live far away in Texas, his friends are still close, kindred spirits," says Sylvia. "I'm kind of an adopted Eagle," she laughs.

"The professors at BC gave me the gift of an education and opportunities I can never repay. We hope to make a difference with this gift." Matt says. "Over the years, BC has advanced, strengthened, and grown, integrating the curriculum with changes in the modern world and the modern economy. It's our hope to play a small part in supporting that important effort."

From Parents to Partners

This family's commitment to Boston College leaves a lasting impact.



or years, Charlotte Teplitz '24 had a secret. Something she couldn't tell anyone until May 2024.

Charlotte was Baldwin.

According to her parents, Kathryne Lyons, P'24 and Jonathan Teplitz, P'24, the role was meant to be. When Charlotte was deciding among various college offers, she knew exactly what she wanted: a school with a great theater program, strong academics, big school spirit, football games, and tailgating. Boston College checked all the boxes—plus the opportunity to try out to portray Baldwin at games and events. Charlotte's special talents and experience on the stage and as an ice hockey goalie helped her land the coveted role.

At BC, Charlotte's journey not only fulfilled her desire for a vibrant college experience, but also ignited a deeper passion within her. Reflecting on their daughter's undergraduate years, Kathryne and Jonathan are proud of her growth. "Kathryne and I always taught our kids to find their passion, work toward it, and never give up on it if you don't have to," Jonathan says. At BC, Charlotte was able to fuel her passion for the dramatic arts through stage management, honing new skills through coursework and as treasurer of the Dramatics Society—ultimately shaping her career trajectory beyond graduation.

Earlier this year, Kathryne and Jonathan established a deferred charitable gift annuity (CGA) with BC. A charitable gift annuity is a simple contract between a donor and the University. In exchange for cash or securities, the donor and/or their named beneficiaries receive fixed payments for life. At the passing of your named beneficiaries, BC receives the remainder of the gift.

"When you get an opportunity to have something that is a good piece of your investment portfolio and gives back to the institution that you care about, it's a win-win," says Kathryne, admitting they knew little about CGAs until BC's Office of Gift Planning presented it as an option. "We were pleasantly surprised by it," she continues. "It's not just writing a check; it is a donation and an investment in BC's future."

With Charlotte's spring graduation still fresh in their minds, Kathryne and Jonathan have also been reminiscing about their four-year journey as BC parents and as members of Parent Partners and the Parents Leadership Council (PLC)—two groups that their CGA qualified them to join. They deeply valued having an expansive network of BC parents through the highs and lows. "The opportunity to connect with fellow parents, whether through tailgating on campus or virtual gatherings, has been invaluable," Jonathan reflects. "Especially

during the tumultuous year of 2020, when lockdowns kept us physically distant from campus, these connections became lifelines." One of their favorite online gatherings was a molten chocolate cake cooking demonstration organized for PLC members.

"It was a fun and creative way to create community at a challenging time for everyone," says Kathryne.

"For us," Jonathan says, "having a robust network—whether as a student, parent, or professional—is paramount. Knowing there's always someone just a phone call away, ready to offer support or solutions, can be incredibly reassuring."

Although Charlotte/Baldwin has graduated, Kathryne and Jonathan view their connection with the Heights as enduring. They intend to continue to catch a football game or two and, of course, stay connected thanks to the deferred CGA.

"Education is a fundamental value we uphold and support," says Kathryne.
"Our commitment to the University isn't based on what it has done for us.
It's about the transformational impact it has had on



Show your support with the plan that is right for you

When BC parents Kathryne Lyons and Jonathan Teplitz explored the various ways they could support Boston College (see previous page), a deferred charitable gift annuity (CGA) stood out as the best option for their portfolio—plus it qualified them to join the Parents Leadership Council and Parent Partners. "The CGA is a way for us to show commitment to BC and also get something back," says Kathryne. "It's a give and get—and demonstrates our belief in the future of the institution."

Charitable Gift Annuities

A charitable gift annuity is a simple contract in which you make a gift to Boston College and you—or other beneficiaries you name—receive fixed payments for life.



HOW IT WORKS

In exchange for a minimum gift amount of \$25,000 in cash or securities, you and/or your beneficiary will receive fixed income for life, backed by the assets of the University. At the passing of your named beneficiaries, BC will receive the remainder of the gift.

- Your gift annuity payment amount is based on your and/or your beneficiary's age.
- You also may be eligible to claim a charitable income tax deduction in the year in which you make your gift.
- Payments can begin immediately or you can choose to defer your income like Kathryne Lyons and Jonathan Teplitz (see previous page).
- If you are 70 1/2 or older, you can also make a one-time taxfree Qualified Charitable Distribution (QCD) from your IRA in exchange for a CGA.



IRA Qualified Charitable Distribution

HOW IT WORKS

Qualified donors can use their Individual Retirement Account (IRA) to make an outright gift to Boston College and avoid income tax from the IRS on the distribution.

In order for the IRA transfer to qualify:

- You must be 70½ years of age or older when the gift is made.
- Charitable distributions cannot exceed \$105,000 per IRA holder in a tax year.
- Transfer can be from traditional, rollover, or inherited IRAs, as well as inactive SEP and SIMPLE plans.
- Transfer must be made directly from the IRA administrator to Boston College.

You cannot take a charitable deduction for this type of contribution. The tax benefit you receive is excluding this contribution from your gross income, therefore not having to pay federal income taxes on it.

Legacy IRA

Under certain circumstances, a donor who is 70 ½ or older can make a one-time tax-free Qualified Charitable Distribution (QCD) from their IRA in exchange for a charitable gift annuity (CGA). For details and qualifications, please visit **bc.edu/legacy-ira**.


